## BUILD RETIREMENT INCOME WITH ANNUAL ANNUITIES

Note in the chart at right that the older you are, the higher the annuity rate and the greater your income payment. The amount of your tax deductions are generally higher the older you are, as well.

For these reasons, you may wish to create additional gift annuities each year. Over time, your income will build, along with the amounts you have given to support the mission of Children's National.

#### The Gift That Gives Back

Uncertainty in the stock market and low interest rates continue to affect many people's cash flow and possibly their charitable contributions.

Fortunately, there are ways to enjoy increased income while also making a meaningful gift to Children's National. In the following pages, we explore the **charitable gift annuity**, a gift plan that allows you to make gifts that provide you and/or a loved one with more spendable income at lower tax rates.

#### How gift annuities work

Under the terms of a gift annuity, you make a gift of cash or other appropriate property to Children's National through a simple agreement. Payments are backed by all of Children's National's available assets.

Gift annuities offer many benefits:

- You will receive regular payments that never decrease in size or frequency, regardless of changes in the economy.
- Payments are made for your lifetime, so there is no concern about outliving this source of income.

- A federal income tax deduction is available when you itemize your deductions.
- Part of each payment is usually free from federal income tax for a designated period of time.
- You may enjoy capital gains and estate tax savings.
- Payments can also benefit loved ones and friends, if you wish.

### **Take Care of Loved Ones**

A Children's National Gift Annuity can result in welcome gift, estate, and income tax savings while accomplishing the following goals:

- Providing payments for one's life and for the lifetime of a surviving spouse. Payment rates for two persons' lives vary with the ages of the individuals. See page 2 for representative rates.
- Ensuring an income supplement for your parent(s), other loved one, or a friend. If you are furnishing regular support to your parent(s)
- from after-tax dollars, a gift annuity can provide a reliable income for life for a loved one with tax savings to you. The annuity payment rate is based on the age(s) of the person(s) receiving the annuity income.
- **Helping with college expenses.** You may have a grandchild (or grandchildren) who you would like to help with education expenses. Gift annuity payments, if they are not needed to supplement your own income, can be a wonderful way to accomplish this goal.

## **Use Appreciated Property to Make a Gift**


You may receive special tax savings and other benefits when you fund a gift annuity using low-yielding stocks, bonds, mutual funds, or other investments.

#### For example

Mrs. Hartzen, age 82, has stock worth \$20,000 that currently yields only 1%, or \$200, per year. She invested just \$5,000 in the stock a number of years ago. If the stock were sold today, she could owe capital gains tax on the \$15,000 increase in value.

Instead, she uses the stock to fund a gift annuity for her benefit. At her age, she will receive an annual annuity of \$1,600, or 8% of the amount of her gift.

In addition, Mrs. Hartzen is entitled to an income tax charitable deduction of over \$10,000 in the year of her gift. She also avoids capital gains tax at the time the annuity is created, avoids some capital gains tax completely, and is pleased to learn that a large portion of her payments will be taxed at lower capital gain rates for the first 8 years.



The stock is removed from Mrs. Hartzen's taxable estate, possibly saving her heirs a significant sum in estate taxes.

## **Tory's Story**

Six years ago, Wendy Silver's 2-year-old daughter Tory was diagnosed with cancer. "When I first began this journey," says Wendy, "I felt very much alone."

When Tory complained of a stomachache that would not go away, Wendy brought her to Children's National. Tory was diagnosed with Stage III Wilm's Tumor, a childhood kidney cancer.

Wendy's initial reaction was disbelief, but she was encouraged by the staff at Children's Hospital. Surgeons removed Tory's right kidney, and Tory went through chemotherapy and radiation therapy.

For many months, Wendy was afraid Tory's 2-year-old body could not withstand the rigors of multiple surgeries, chemotherapy, radiation, and cancer. Six years later, how-

ever, Tory is a happy, healthy, and playful 8-year-old.

Tory's four siblings were treated by hospital psychologists to help them cope with the strains on the family.

"This helped a great deal," Wendy says, "and I know these resources are still available to our family, should we need them."

Children's National continues to "treat the family" while caring for our small patients. Tory and Wendy recently visited the new Inpatient Tower and were impressed by the bright colors, private rooms, and special facilities that consider family needs when a child is hospitalized.

"Children's National is a precious resource for our community's children and families," Wendy says. "Tory's recovery has been a miracle and a gift."

# Giants in the World of Neuro-Oncology

"I always wear a smile with every outfit," says Brittany Wagner. Her high school prom and graduation photos prove her motto. Brittany is being treated

through the **Children's National Brain Tumor Institute** with a combination of drugs that were tested through one of many clinical trials the Brain Tumor Institute makes available to patients in the region and around the country.

Several years ago, Brittany was diagnosed with glioblastoma multi-

forme (GBM), a particularly aggressive type of malignant brain tumor. She underwent surgery and radiation therapy at Children's National, and was treated with a new medication.

Brittany was fortunate to live in the D.C. area and have the Children's National Brain Tumor Institute close by.

Led by Roger J. Packer, MD, the Brain Tumor Institute is one of only nine centers selected by the National Cancer Institute to perform innovative

clinical research in neuro-oncology.

The multidisciplinary Brain Tumor Institute also draws on the talents of neurosurgeons, as well as oncologists and researchers.

"They are giants in their worlds and super guys in mine," says Brittany. "We

beat the odds and I made it to my high school prom and graduation. Now I plan to go to college because I want to be a teacher. That way, I can make my contribution to the world of research and care."
